Intended Service:	Water tightness testing system used on ABS vessels and offshore units. Primary function is to test doors for water tightness but can also be used to check tightness of doors, windows, ramps, opening and bulkhead.
Description:	The system comprises a micro-processor controlled transmitter, containing 13 off 40 KHz emitters arranged on a dome, producing uniformly distributed omni-directional ultrasound field and a handheld ultrasonic receiver unit which, connects to a 10 mm diameter inspection microphone on a telescopic arm thereby allowing tightness measurements in dBuV values.
